AGENDA ITEM: Approve 2020-21 District Budget/Tax Levy (Action)

As discussed during the Finance Committee Report, the district is required to certify a tax levy prior to November 1. Now the district knows the three variables to this year's revenue limit (resident students, equalized property value, and state aid), please see the attached document that the Finance Committee reviewed in making this recommendation. The Finance Committee supports the given motion/resolution to be brought forward to the entire board.

ADMINISTRATIVE RECOMMENDATION:

The administration is recommending the following motion be made:

"I make a motion to recommend to certify the tax levies of: Fund 10: \$4,530,700 Fund 38: \$63,916 Fund 41: \$1,000 For a total tax levy of \$4,595,616

Be it resolved that the property tax levy to fund the 2020-21 Merton Community School District operations be set at \$4,595,616 and that the necessary certifications be forwarded to the clerks of the appropriate municipalities."

This establishes a mill rate of \$4.35 per \$1000 of valuation for property tax purposes.
