A la Carte

A la carte snacks and beverages are available to students at Merton Intermediate. We are excited to offer a variety of fun foods such as freshly baked cookies, ice cream, chips, milk, 100% juices, and water. Students must have funds available in their account to purchase these items.

Students at the Primary school can purchase extra milk for \$0.25. As a reminder, all reimbursable/complete meals come with milk. Primary students may also purchase extra entrees or sides if there are funds available in their account.

Now is a great time to check your student(s) account on Skyward for balance, ala carte limits, and purchase holds/blocks.

Note: If your child has an ala carte limit of less than \$0.75, they will not be able to purchase any extra sides at the Primary school. The minimum at the Intermediate school is \$0.65.

How Do I Pay for Lunch?

The Merton Community School District requires payment in advance for school meals and milk. The fastest and easiest method is to pay online via family access. You may also send cash or check (payable to Merton Community School District) in an envelope labeled with your child's name to the front office.

During the school year, money received in the morning will be recorded in time for the **next** day's lunch.

Free/Reduced Priced Meal Information

With the expiration of USDA waivers, school meals are no longer free for all. The last status determination carries over until October 16, 2023, so you must submit an application to prevent a disruption in meal benefits.

The data from these applications also allows the district and/or your family to qualify for additional aid in some instances.

Applications can be printed from the district web page. Paper applications are also available in the District Office.

We serve food kids love to eat! Freshly Baked Pizza, Crispy Chicken Sandwiches and Made-to-Order subs are just a few...

<u>American Classic</u> station rotates daily with items such as Mashed Potato & Popcorn Chicken Bowl, Sweet n' Sour Chicken, Breakfast-for-Lunch and more!

<u>Grilled</u> station rotates 2 choices daily with items such as Mini Corn Dogs, Hamburger, and BBQ Pulled Pork on a Bun

<u>2mato</u> station offers homemade cheese and pepperoni pizza MWF with specialty flatbreads T/Th **<u>So Deli</u>** station offers build you own sandwiches daily.

On the Go station offers grab and go parfaits and salads for times when students are in a hurry or just don't want to wait.

A meal isn't complete with out a fruit and/or vegetable, so we offer a hot vegetable of the day, a variety of fresh vegetables on our salad bar, and variety of fresh, canned, and dried fruits on our salad bar.

What is the Cost?

Merton Intermediate offers paid student pricing in two tiers. Both tiers include entrée, fruit and/or vegetable, and milk. Students must take a fruit and/or vegetable to make it a complete/reimbursable meal. Please encourage your students to do so to get the best pricing!

Tier 1: \$3.40 (American classics, Grilled, and On the Go)

Tier 2: \$3.75 (Tuesday Classic, So Deli, and 2Mato)

If you think you may qualify for free or reduced priced meals, please complete an application each school year.

You can add money to your student's lunch account via efunds.
