This includes harassment, reporting, investigations, etc...School Districts are required to adopt policies meeting the new regulations. Dr. Russ has been working with WASB (legal council) to develop these policies to meet the new regulations. Dr. Russ will be finalizing these on Monday with Bob Butler. WASB just finished up their recommendations for districts to adopt.

Full policy will be shared with the board prior to the meeting, and placed in this document for public viewing. The policies that will be presented will represent compliance with the new laws. Final approval will have to be done prior to August 14, 2020.
