<u>Sonos</u> Latin Station Tuesdays featuring BYO Nachos or BYO Burrito.

Tier 2 pricing (\$4.15) is always depicted with an \*asterisk on the menu at this station. All meal tiers in all categories qualify for paid, free and reduced.

#### Tier 1: \$3.70

**Grilled** station features Cheeseburger with Fries daily, and a rotating appetizer to include Chicken Tenders, Nuggets, Pizza Crunchers and more.

On the Go station offers grab and go smoothies and fun lunches.

#### Tier 2: \$4.15\*

**<u>2mato</u>** Pizza station offers homemade cheese, pepperoni, and sausage pizza Monday thru Wednesday, French Bread Pizza on Thursday and Big Daddy's Friday.

**Deli** offers Premade Wraps, Salads and Sandwiches.

Milk and our Fresh Fruit and Vegetable Bar is included with every meal.

A meal must have at least one vegetable or fruit. Your student will receive a gentle prompt to take a fruit of vegetable with a meal to qualify for the meal price.

<u>Ala Carte:</u> Smart Snack items including baked chips and crackers, whole grain cookies, bottled and canned waters, juices and ice cream treats. Second servings also fall into this category. Ala Carte items can be purchased if your student has money in their account. You can add money to your student's lunch account via eFunds.

#### It's Time for Lunch! Elementary Lunch \$3.45

- Our lunch menu at Primary consists of three meal options daily. Options 1 and 2 are Hot Entrees and Entrée 3 is a Cold Fun Lunch, Sandwich or Wrap.
- Second Entrees are available for \$2.50 with funds in your account.
- Our balanced meals all come complete with sides, milk and our fruit and vegetable bar.
- A daily fruit or vegetable completes a healthy meal. If your child does not choose a fruit or vegetable, they will receive a gentle prompt from our server.
- The self-service condiment station features ketchup and ranch dressing. Utensil and napkin dispensers are touch free.
- Milk comes with the meal but is also available to purchase individually for \$.50 per carton when a meal is not purchased.
